#### **History:**

In the late 1990's Fr Kevin Canty cm (working first with Sr. Joan Ryan sgs, then Sr. Lianella Girardi rsj), facilitated a program for the formation of Spiritual Directors, initially under the auspices of the Adelaide Catholic Diocesan Spiritual Directors' Association, then through the ACD: Catholic Theological College. In 2003, Sr. Carina Flaherty ibvm became the facilitator of the program and remained so until 2011 when Valerie De Brenni took on the role. In 2013, when the ACU and the Archdiocese of Adelaide entered a partnership, the Spiritual Directors' Formation Program no longer was attached to the CTC/ACU. It is presently offered under the auspices of the Catholic Archdiocese of Adelaide. Upon satisfactory completion of the Program participants receive a Certificate of completion from the Catholic Archdiocese of Adelaide. In 2020 we undertook to apply for formal recognition from AECSD (Australian Ecumenical Council for Spiritual Direction) and were granted this accreditation.

#### **Contemplative ethos underpinning the formation program**

The Archdiocese of Adelaide Spiritual Directors' Formation Program is a two-year program underpinned by Ignatian spirituality. This contemplative spirituality encourages a reflective approach to living, insists that God is present in our world and active in our lives, inviting us into response. It uses a contemplative form of prayer and has a reverential attitude towards creation. This contemplative spirituality is a pathway to deeper prayer, good decisions guided by keen discernment, and an active life of service to others.

This model of formation aims to integrate a contemplative stance in the student and the adoption of a contemplative stance towards the directee. It is evocative because its underlying philosophy is to evoke personal and spiritual growth in the student which will flow on to the directee.

We believe that Spiritual Direction is a vocation, consequently our program is designed to help individuals who are feeling drawn to the ministry of spiritual direction to explore their desire and abilities for this ministry and to discern if indeed God is calling them to this ministry.

This program is financed by the Catholic Archdiocese of Adelaide but welcomes applications from those belonging to other Christian denominations. We value diversity and the ongoing sense of collegiality that grows from the shared experience of learning within a community of people who share a common goal.

#### **Program Structure**

This two year structured program explores the ministry of spiritual direction particularly within the context of Ignatian spirituality and is made up of both theoretical (CA 1/2: The Ministry of Spiritual Direction) and practical studies (CPR 01/2: The Ministry of Spiritual Direction: Practicum and Supervision) conducted in a contemplative learning environment. It explores the theology, focus, process and current models and definitions of Spiritual direction. It gives focus to the experience of spiritual direction from the standpoint of both the director and the one directed. Emphasis is given to the personal transformation of participants in the program because the personal experience and growth of the spiritual director is seen as a key source of knowledge for one engaged in the ministry of spiritual direction. Learning processes include lectures, written assignments, designated readings, triads, group discussions, role plays, theological reflection, prayer and supervision.

#### This 2 year Program includes:

- 1. Outcomes-Based Contemplative Learning (Thursday evening) comprising 62 three hourly sessions
- 2. Outcomes-Based Contemplative Learning of 4 intensives (Fri evening /Saturday) per year in a structured program with lectures, readings, discussion, workshops and
- 3. A spiritual direction practicum with 28 contact hours of one-to-one supervision between a participant (supervisee) and a supervisor, in addition to peer supervision and supervisory learning in a group context, and the completion of at least 70 hours of giving Spiritual Direction plus
- 4. Participation in a silent directed retreat during the two-year program (not included in the contact hours above)

#### **Learning Outcomes**

By the completion of the program students will:

#### **Learning outcome 1:1**

 understand the contemporary ministry of spiritual direction and reflect upon their own experience of being directed.

 have knowledge of, and personal transformational engagement with, the biblical, theological and Ignatian basis to the ministry of spiritual direction and reflect upon how these influence their own attitudes and responses to God, to others and to the cosmos.

#### Learning Outcome 7.1

 Understand the psychological dimensions of the spiritual life and of spiritual direction.

#### CPR 01/2: The Ministry of Spiritual Direction: Practicum and Supervision

This program incorporates a regular time of prayer, reflection and sharing. Participants learn to direct through active engagement in the work of spiritual direction with weekly supervision of actual direction sessions and regular personal spiritual direction. Verbatims are used as the basis for role-playing actual direction sessions.

The Practicum involves guidance through the process of spiritual direction, and giving spiritual direction, with supervision, starting with 1 or 2 and building up to 4-5 directees. 70-80 hours of spiritual direction are required for the successful completion of the program. There is fortnightly individual supervision during each semester and supervision during breaks when required.

#### **Learning Outcomes:**

By the completion of the program students will:

#### Learning outcome P1:1

 hold a contemplative attitude to themselves and adopt a contemplative stance to their directees.

#### **Learning outcome P2:1**

 integrate a contemplative approach into their lives demonstrating a clear understanding of, and personal transformational engagement with, the principal spiritual practices consistent with the Ignatian contemplative ethos and develop proficiency in utilising these spiritual practices.

#### **Learning outcome P3:1**

 understand the focus and tasks of the spiritual director, especially developing the ability to listen deeply, to attend to what they hear, evoking from directees the lessons learned and discoveries made, about God's action in their lives.

#### **Learning outcome P4:1**

• be able to lead others in a variety of prayer and the contemplative traditions

#### **Learning outcome P5:1**

 develop competency in providing spiritual direction, developing their own gifts and special strengths in this ministry, and recognise the areas in which they will continue to need further development

#### **Learning outcome P6:1**

 understand and comply with National Guidelines and Code of practice for spiritual direction.

#### **Program Requirements**

- a) It is expected that participants will have completed previous tertiary study in areas that support this program (e.g. theology, Scripture, spirituality) or will have considerable pastoral experience. This study is a particular requirement for catholic participants in order to be formally listed by the Archdiocese of Adelaide as a spiritual director.
- b) It is required that participants have spiritual direction themselves for at least 12 months before entering this program. It is helpful to have made at least one silent directed retreat before application is made. Applications are welcome from people across Christian denominations. Only up to twelve people are accepted into each program.

#### c) Course commitment

4 semesters over two years, including 4 Intensive weekends (Friday evening/Saturday).

Weekly commitment (contact hrs) during semester are as follows:

Meet 5.00pm-8.00pm one night a week during term (See Appendix 4A/B)

Meet with supervisor once a fortnight during semester (1 hr)

Meet with directees for spiritual direction (2-3 hours a month)

#### d) Application

For the Application form and process please see P. 15-17 of this Handbook.

#### **Fees and Charges:**

Tuition Fees are \$1,300.00 per year. (At this stage) This fee covers all handouts, booklets, and supervision costs, but does not cover required text books. Students may apply to pay yearly fees in two instalments of \$650.00. If a student withdraws from the program after the first two weeks of term of year 1 or year 2 they forfeit the \$450.00 paid for that term. The cost of the retreat in year 2 is approximately \$750.00 this covers accommodation and direction costs. (This may increase subject to an increase in Retreat House or spiritual direction fees).

#### **Application Process**

- 1. Complete the Application form
- 2. Complete Reflection Paper:

In about 1000 words (on separate sheet) please reflect upon: your family context, how you understand your relationship to Church and any previous experience you have had that may develop skills pertinent to Spiritual Direction. Explain why you feel drawn to begin this formation program.

#### 3. Arrange letters of recommendation:

You will require two letters of recommendation, one of these should preferably be from your parish priest or a person in leadership within the church. We recommend that you do not ask your spiritual director for a letter of recommendation as this may blur the director/directee relationship. These should be sent directly to the contact below.

See Appendix 3 for guidelines, these should be forwarded to those who have agreed to support your application.

- 4. You will receive a letter acknowledging your application
- 5. The spiritual direction team involved with the program will read and discuss your application. If successful you will be invited to the next level of discernment and will required to attend an interview.
- 6. You will receive a letter giving verification of your acceptance/non-acceptance into the program.

#### **Appendix 3**

Guidelines for those writing a recommendation for application into Catholic Archdiocese of Adelaide Spiritual Formation Program.

The following are aspects that may help to guide you as you reflect upon the suitability of the person you have agreed to recommend:

- 1. Does this person express a sense of call to the ministry of spiritual direction?
- 2. Do they demonstrate a capacity to listen empathetically and sensitively?
- 3. Do they have enough life experience to enable them to respond with wisdom to people from diverse lifestyles and with different levels of experience?
- 4. Do they show an openness to learning from their and others' lived experience?
- 5. When reflecting upon this person to you see evidence of a maturing spirituality and openness to other worldviews?
- 6. Does this person demonstrate a commitment to prayer and reflection?
- 7. Has this person been engaged in receiving spiritual direction for some time?

# Appendix 6 Process of Review of Participant

During this two-year program the following aspects of discernment are put into place with regards to the suitability of the person for the ministry of spiritual direction.

#### Process of Review of participant:

- 1. The language used in this program is 'discernment'. We believe that spiritual direction is a vocation and that this program helps discern suitability for call to this ministry. Consequently, we encourage a mind-set that requires openness and discernment.
- 2. When an application is put forward it includes two letters of recommendation. Those writing a letter are asked to consider seven questions that may help to guide the process. (See Appendix 3, Program Outline Handbook), the applicant also has an interview. These help the Team to discern the suitability of the applicant for participation in the Program.
- 3. In the first year a participant is required to write 8 reflection papers. At the end of the first year the participant writes a 2000-word paper that involves self-evaluation. A member of the Team meets with each participant to discuss areas of growth and success and areas that require further growth.
- 4. Each participant is involved in monthly spiritual direction and a fortnightly meeting with their supervisor. This assists the discernment process.
- 5. In the middle of the second year of the program the Team meet to evaluate each participant using the seven questions in Appendix 3; feedback from directees and feedback from supervisors. If there are any concerns a meeting is set up with the participant and these are discussed. The participant is encouraged to discern, over the next months, their own sense of vocation/lack of vocation and suitability using the questions from Appendix 3 and feedback from their directees and supervisor.
- 6. Generally, participants in the program after discernment are able to make an informed, discerned decision regarding their suitability as a Spiritual Director. In the event that there is a difference of discernment that will not be addressed by further training, the Team make the final decision in relation to the granting of a Certificate of recommendation.
